1. Complete the Application Process (submit an application and supporting documents).

You may apply online at nv.edu/Apply, in person or by mail. You will receive an acknowledgement letter when your application has been processed. (See below for non-degree and underage students.*)

Supporting documents for new and transfer degree-seeking students include:

- **Proof of high school completion:** High school diploma, GED, or official high school transcript with date of graduation. (required for acceptance and to receive financial aid)
- **Immunization requirements:** All degree seeking students born after 12/31/56 are required by state law to submit immunization documentation for 2 doses of Measles, Mumps, and Rubella (MMR). Those born as of 1/1/1980 also need to submit documentation for 2 doses of Varicella (Chicken Pox).
- **Previous College transcripts:** Submit **Official** transcripts to qualify for transfer credits. **Unofficial** transcripts may be used to waive the placement test or meet prerequisite requirements. Send unofficial transcripts to nvcc@nv.edu.
- **SAT/ACT or GED test scores (optional):** Submit scores to determine if Math and/or English placement testing can be waived. See www.nv.edu/apply (step 3).

2. Apply EARLY for financial aid!

Go to www.fafsa.ed.gov to obtain information and apply for financial aid. Our school code is **006982**.

3. Schedule, Prepare and Take the Accuplacer® Assessment Test (placement test).

The Accuplacer® is required unless it has been waived using SAT/ACT or GED scores or previous college credits (see above). Go to www.nv.edu/Accuplacer to schedule a test at the Waterbury or Danbury Campus.

4. Schedule a New Student Registration session

Missing items may be turned in on the day of your appointment. Go to www.nv.edu/walkin to schedule your New Student Registration session online.

5. Register for Classes.

Students must be accepted in order to register for classes. New, degree-seeking students are not eligible to register online for classes. Transfer students may register online via www.my.comnet.edu once they are accepted and receive their student ID number. Students should be prepared to register and make a payment at their New Student Registration session.

6. Pay your Tuition.

Payment is due at time of registration. We accept cash, checks, credits cards including: VISA, MasterCard, American Express or Discover. A payment plan is also available. Students who have received a financial aid award may not need to make a payment. These students should discuss payment responsibilities with the financial aid staff.

***Non-Degree and Underage Students** must be part-time and not currently pursuing a degree/certificate program at NVCC. They are ineligible for financial aid. You may apply online at nv.edu/Apply, in person or by mail. Testing may be required depending on course selection. **Non-Degree Students** may register online via www.my.comnet.edu once they receive their student ID number. Previous, unofficial college transcripts are required to register for classes with prerequisite requirements. **Underage students** and a parent or guardian are required to meet with an advisor to register for classes.

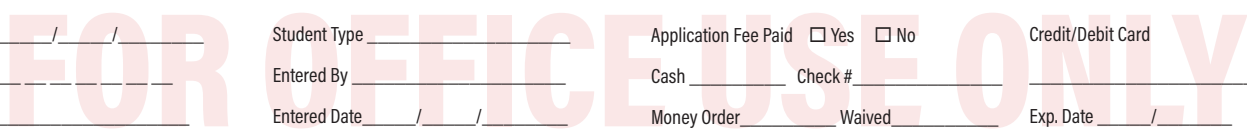
